

Privacy Policy

Introduction

The website <https://www.crescimbeni.com/> (the "Site") belongs to Crescimbeni ("Crescimbeni"), with legal address at Vuelta de Obligado 1923, 1 "A", City of Buenos Aires, Argentina.

Crescimbeni respects and protects the privacy of visitors and users of the Site. Thus, this Privacy Policy is intended to inform you about how your personal data will be used so that you can freely decide whether you wish to share data with Crescimbeni when so requested through the Site. If you do not want Crescimbeni to obtain personal identifiable information about you, you should refrain from providing it.

What data do we collect from you?

When using the Site, you may be required to provide certain personal data (the "Personal Data") such as:

- a) Your first and last name, email address, organization to which you belong, job title, and country, when you sign up to receive emails from us, when you download content or when you update your personal details and preferences for email deliveries.
- b) Contact information, such as first name, last name, email address, and organization to which you belong, when you complete the "Contact us form" or send an email.

You are not obligated to share your Personal Data with us, but if you do not provide it or if you provide false or inaccurate data, Crescimbeni will not be able to carry out the purposes described in this Privacy Policy.

For what purposes do we use your Personal Data? Your Personal Data will be used for the following purposes:

- a) To respond to the requests and queries you have made through the Site.
- b) To improve Site functionalities.
- c) To contact you in the future and inform you about activities that Crescimbeni carries out and that we believe may be of interest to you, including, but not limited to, talks on a current topic, conferences, newsletters, events, and institutional news.

With whom do we share your Personal Data and for what purposes?

We may share your Personal Data with third parties where necessary:

- a) So that those third parties can provide services to us in connection with the operation of the Site. For example, we may share your Personal Data with our service providers to perform certain functions on our behalf or to host our databases. In any case, Personal Data will not be used by third-party service providers for any purpose other than that for which Crescimbeni hired them.
- b). To comply with applicable laws or regulations, judicial or administrative proceedings, and/or requests from competent authorities.
- c) To protect and defend the rights of Crescimbeni.
- d) To comply with an order of any competent state body, government agency or competent court.
- e) To protect its vital interests or those of any other person.
- f) During an audit process of Crescimbeni, with the auditors and their principals, always subject to confidentiality duties.

International Transfer of Personal Data

When Personal Data be shared with third parties as described in this Privacy Policy, Personal Data may be transferred outside of Argentina, including to countries whose legislation possibly does not offer a standard of protection for personal data equivalent to that of Argentina. In that case, bear in mind that by providing your Personal Data you are consenting to any such transfers.

About your rights

You have the right to request and obtain information about what Personal Data pertaining to you be stored by Crescimbeni. You also have the right to request amendment and updating; and, if applicable, to delete your Personal Data. We hereby inform you that the Agency for Access to Public Information, in its capacity as controlling agency pursuant to Law No. 25.326, is responsible for dealing with complaints and claims filed by individuals whose rights are affected by any breach of personal data protection regulations currently in force.

Use of cookies

Crescimbeni does not use its own cookies on the Site, but third-party cookies may be used as an analytics tool to measure and generate statistical reports on user interactions on the Site and applications.

The collection of this data allows us to count visits and traffic sources to evaluate the performance of the Site and to improve it. It also helps us to know how the Site is used and which sections are the most or least visited. At the same time, it allows us to offer information on products and services that may be of interest while browsing the Site or specifically through any automated means.

Site security
